

- More restricted budgets
- Increased pressure to delivery on time and on budget





It is a standardised way of approaching and talking about projects.

- Will it guarantee my project is a success?
  - No (Guarantee is such a strong term.).
- Can I be successful doing it my way?
  - Maybe
- Will it make project handover to others easier?
  - Yes
- Will it make my project reporting more transparent?
  - Yes

# If PMI will not guarantee success what will?

Pay attention....

- Analyse your project
- Understand what are the risks
- Identify those that are important
- Develop reasonable mitigation
- Know when your in trouble and take appropriate action.





# What is Risk?

- ISO 31000:2009 – Risk Management Principles and Guidelines defines risk as “*the effect of uncertainty on objectives*”.

effect = deviation from the expected

- *ISO 31000:2009* defines risk management as “*coordinated activities to direct and control an organization with regard to risk*”.
- Impact (Severity) of Harm and Likelihood it will occur






- Project






